## **Contact Letter**

Dear Parent and/or Guardian

We are contacting you because your daughter was participating in our after school programming.

We would like to support participants who wish to continue to work on their apps and business plans in order to submit to the Technovation global competition.

To do this, <u>we require your permission</u> to invite your daughter to our online mentoring sessions which will be run as follows:

- through video conferencing which has the highest cybersecurity compliance;
- with at least two Garda vetted mentors present always, to supervise all interactions, in keeping with child welfare best practice;
- and sharing no information about your daughter with third parties in any capacity, per GDPR guidelines.

Your child's safety and well being is of the utmost importance to us. When it comes to interactions between adults and children, our organisation takes every precaution necessary and then goes several steps further to ensure no participant is ever at risk.

All online sessions must be supervised by **two mentors**. Lead Mentors will enter into the site as "Host" and will not permit any participant entry until both mentors are present.

In light of recent "zoombombing" incidents where public online sessions for children were crashed by individuals posting obscenities and/or pornography, Lead Mentors must make certain, when hosting sessions, that:

- (1) he/she is aware of everyone who has joined the call;
- (2) if participants do not have their video on, they must identify themselves and the Lead Mentor should drop them immediately from the call if the participant does not respondthis means the Lead Mentor asks whomever appears to say 'hi' and to update on what she is working on (that the name is familiar isn't enough); and
- (3) no mentor shares session details on any social media from now forward.
